vulnerable children

Dear all,

The Coalition of NGOs for Child Protection, which represents 31 non-governmental organizations in the field of protection of children's rights, expresses its concerns about the fact that civil society organizations in the field of social and health services have been left without funding as a result of not announcing regular public calls by MLSW and MoH for the provision of services.

The Covid-19 pandemic has worsened the situation of vulnerable children, many of whom have been left without the necessary services. Non-Governmental Organizations that provide direct services, especially day centres and those that provide direct services in the community for children with disabilities, children involved in hard labour, children working in street, neglected children, and so on, have closed their services in March 2020 by implementing recommendations for National Public Health Institution, by providing only virtual services.

At this stage it is important to take the necessary steps to mitigate the consequences for children by providing quality direct services, through sustainable financing of services for vulnerable children, increasing support for service providers and contracting them during this period of difficult during and after pandemic.

Non-governmental organizations providing direct services to vulnerable children are financially supported by the central level (MLSW and MoH), international donors, municipalities and the business sector. MLSW and MoH through the process of public call, every year have funded organizations licensed to provide direct services to vulnerable children and citizens in need of services. This year, as a result of the Covid-19 pandemic situation, there has been no call for financial support from licensed organizations providing direct services. Also, support from the business sector has declined significantly due to the situation created by the pandemic.

For the reasons mentioned above, KOMF requires:

- Urgent announcement of regular annual calls for funding Non-Governmental Organizations for the provision of services by the Ministry of Labour and Social Welfare and the Ministry of Health.
- Increasing the budget for financing direct social and health services provided by the nongovernmental sector.



KOMF notes that the general economic situation has been worsed as a result of Covid-19 pandemic and budgetary revisions may be made. KOMF demands that in the framework of budget revisions, the budget of financing direct social and health services for vulnerable children provided by the non-governmental sector, should be increased.

KOMF considers that during budget planning and reviews, the protection of the fundamental rights of children should be an absolute priority for the Government of the Republic of Kosovo, placing this priority before capital investments.

Considering the common interest of all citizens to enjoy social welfare, KOMF demands your attention in support of Non-Governmental Organizations licensed to provide social and health services during and after the Covid-19 pandemic.
